Not really sure where this information needs to be submitted to, however below is a brief about one of the partnership develops happening in Hull which may be of interest:

Early last year, after realising there was very little opportunity available in the city to meet regularly with other providers of Older Peoples services, I set up the Older People's Partnership Group (OPPG). The OPPG is open to any older person, organisation, service or group, regardless of size, and aims to provide a forum for sharing information, raising issues, good practice, advice, partnership working, opportunities for working better together, creative thinking and support. The OPPG meets on a monthly basis and currently has over 30 members attending regularly, which has resulted in us out growing or meeting space!

The group have worked closely together, and planned and delivered the Older People's Celebrations in Hull over the last two years, more recently in October this year. The events were delivered on very tight budgets, with funding raised by the OPPG, and were hugely successful with thousands of older people, their carers and families attending a wide range of events on activities throughout the week long events. We are currently in the process of trying to secure funding in order to start planning for next year's celebrations as we hope that this will become a regular annual event to celebrate older people in Hull.

The OPPG is a good example of partnership activity, and the efforts we are making in Hull to develop a more joined up approach to service delivery and prevention in order to improve the quality of life for older people living in the city.
