This offers novices a fast, simple learning pathway into the use of word-processing, email, storing images, the internet and Skype. All the less important commands and processes have been stripped out. There are no long complex menus and sub-menus. Instead, a clean simple mode of access to basic functions is transparently obvious. There is built in support in video tutorials by Valerie Singleton.

I have attended at residential care homes and observed for myself how successfully this system achieves its aims. And once the novices have grasped the essentials, they frequently take themselves on to the next stages in computer use. I cannot recommend it too highly as the starting point for hesitant non-users whether old or young.
